Special Educational Needs and Disability (SEND) Policy

This policy is in line with our Teaching and Learning Policy and Single Equality Policy & Accessibility Action Plan and aims to support inclusion for all of our children. The responsibility for the management of this policy falls with the Headteacher; the day-to-day operation of the policy is the responsibility of the Special Educational Needs & Disabilities

Coordinator (SENDCo). The Governing Body, Headteacher and the SENDCo will work together closely to ensure that this policy is working effectively.

High quality teaching is that which is differentiated to meet the needs of the majority of students. Some students will need something **additional to** and **different from** what is provided for the majority of students; this is special educational provision and we will use our best endeavours to ensure that provision is made for those who need it.

The Park Community School will do its best to ensure that the necessary provision is made for any student who has special educational needs and disabilities. We will ensure that all staff in the school are able to identify and provide for those students who have special educational needs and disabilities to allow students with SEND to join in the activities of the school.

The staff and governors of The Park Community School will also work to ensure that all SEND students reach their full potential, are fully included within the school community and are able to make successful transfers between educational establishments. This policy aims to support all members of staff in providing positive whole school approaches towards the learning, progress and achievement of SEND students. With this as an underlying principle, we believe that;

***All teachers are teachers of Special Educational Needs and Disabilities.
Every teacher is responsible and accountable for the progress and development of all students in their class even where students access support from Teaching Assistants or specialist staff.***

Teaching and supporting students with SEND is therefore a whole school responsibility requiring a whole school response. Meeting the needs of students with SEND requires partnership working between all those involved – Local Authority (LA), school, parents/carers, students, children’s services and all other agencies.

School Admissions

No student will be refused admission to school on the basis of his or her special educational need. In line with the Equality Act 2010, we will not discriminate against disabled children in respect of admissions for a reason related to their disability. We will use our best endeavours to provide effective educational provision.

Aims and Objectives

Aims

To provide the structure for a child-centred process that engages students, family, school and other professionals in planning for and implementing high quality, needs-led provision that is consistent across the school. This is to ensure all of our students are able to access the same opportunities for learning and social development achieving maximum progress, fulfilling their potential and promoting their well-being.

Objectives

The SEND Policy of The Park Community School reflects the principles of the 0-25 SEND Code of Practice (2014). The aims of this special educational needs policy are:

- To ensure the Equality Act 2010 duties for students with disabilities are met;
- To enable students with special educational needs to have their needs met;
- To take into account the views of the students with special educational needs;
- To encourage good communication and genuine partnerships with parents/carers of children with special educational needs;
- To facilitate full access to a broad, balanced and relevant education, including an appropriate curriculum for students with special educational needs;
- Make arrangements to support students with medical conditions in conjunction with the Medicines Policy and to have regard to statutory guidance supporting students at school with medical conditions;
- To implement a graduated approach to meeting the needs of students using the Assess, Plan, Do, Review process;
- To develop a culture of inclusion valuing high quality teaching for all learners, with teachers using a range of effective differentiation methods;
- To employ a collaborative approach with learners with a SEND, their families, staff within school and other external agencies including those from Health and Social Care;
- To actively pursue collaboration with other agencies in the interests of our students;
- Set appropriate individual learning outcomes based on prior achievement, high aspirations and the views of the learner and family;
- Share expertise and good practice across the school and local learning community;
- Make efficient and effective use of school resources;
- Have regard to the Code of Practice (2014) for the identification, assessment, support and review of special educational needs;
- To acknowledge the role played by staff other than the SENDCo in delivering the aims of this policy, namely the Behaviour, Learning, Emotional Support Team (BLEST)

Manager and BLEST staff in the Mulberry Centre, the team of staff in the Study and Support Centre and Learning Mentors;

- Have regard to guidance detailed by Devon County Council.

Identifying and supporting Special Educational Needs & Disabilities

Definition of SEND

Students have special educational needs if they have a learning difficulty or disability which calls for special education provision to be made for him/her, namely provision ***which is additional to or different from*** that normally available in a differentiated curriculum. The Park Community School regards students as having a Special Educational Need and Disability if they:

- a) Have a significantly greater difficulty in learning than the majority of students of the same age, or;
- b) Have a disability which prevents or hinders him/her from making use of facilities of a kind generally provided for others of the same age in mainstream schools or mainstream post-16 institutions;
- c) A child under compulsory age has special educational needs if they fall within the definition at (a) or (b) above or would do so if special educational provision was not made for them (Section 20 Children and Families Act 2014) .

Students must not be regarded as having a learning difficulty solely because the language or form of language of their home is different from the language in which they will be taught.

The Park Community School will have regard to the SEND Code of Practice, 2014 when carrying out its duties towards all students with SEND and ensure that parents/carers are informed by the school that SEND provision is being made for their child.

There may be times in a student's school career when they are identified as having a Special Educational Need and Disability. These students will be provided with intervention and/or support that is 'additional to or different from' the normal differentiated curriculum. This may be on an ongoing basis or for a limited time. Many students with sensory and/or physical disabilities may require adaptations, made as reasonable adjustments under the Equality Act 2010.

Areas of Special Educational Need

Under the SEND Code of Practice 2014 students identified as having a special educational need (SEN) will be considered within one or more of the following categories of need:

Cognition and Learning

Children with learning needs may learn at a slower pace than other children and may have difficulty developing literacy or numeracy skills or understanding new concepts. Learning needs may be in addition to or as a result of other special educational needs.

Children with a specific learning difficulty (SpLD) will have difficulties related to one or more of dyslexia (reading and spelling), dyscalculia (maths), dyspraxia (co-ordination) and dysgraphia (writing).

Learning difficulties cover a wide range of needs, including moderate learning difficulties (MLD), severe learning difficulties (SLD), where children are likely to need support in all areas of the curriculum and associated difficulties with mobility and communication, through to profound and multiple learning difficulties (PMLD), where children are likely to have severe and complex learning difficulties as well as a physical disability or sensory impairment.

Cognition and Learning needs include:

- Specific learning difficulties (SpLD)
- Moderate learning difficulties (MLD)
- Severe learning difficulties (SLD), and
- Profound and multiple learning difficulties (PMLD)

Social, Emotional and Mental Health Difficulties

Children may experience a wide range of social and emotional difficulties which manifest themselves in many ways. These may include becoming withdrawn or isolated, as well as displaying challenging, disruptive or disturbing behaviour. These behaviours may reflect underlying mental health difficulties such as anxiety or depression, self-harming, substance misuse, eating disorders or physical symptoms that are medically unexplained.

Other children may have disorders such as attention deficit disorder, attention deficit hyperactive disorder or attachment disorder.

Social, Emotional and Mental Health Difficulties include:

- ODD
- PDA
- ADD
- ADHD
- Attachment Disorder

Communication and Interaction needs

Children with speech, language and communication needs (SLCN) have difficulty in communicating with others. This may be because they have difficulty saying what they want to, understanding what is being said to them or because they do not understand or use social rules of communication.

The profile for every child with SLCN is different and their needs may change over time. They may have difficulty with one, some or all of the different aspects of speech, language or social communication at different times of their lives. Children with autism are likely to have particular difficulties with social interaction. They may also experience difficulties with language, communication and imagination, which can impact on how they relate to others.

Communication and Interaction needs include:

- Speech, language and communication needs (SLCN)
- Autism

Sensory and/or Physical needs

Some children require special educational provision because they have a disability and this prevents or hinders them from making use of the educational facilities generally provided. These difficulties can be age related and may fluctuate over time.

Many children with vision impairment (VI), hearing impairment (HI) or a multi-sensory impairment (MSI) will require specialist support and/or equipment to access their learning. Children with an MSI have a combination of vision and hearing difficulties. Some children with a physical disability (PD) require additional ongoing support and equipment to access all the opportunities available to their peers.

Sensory and/or physical needs include:

- Visual impairment (VI)
- Hearing impairment (HI – including Deaf and hearing impairment)
- Multi-sensory impairment (MSI - sometimes referred to as Deafblind)
- Physical disability (PD).

A Graduated Response to SEND

Early Concerns

The progress made by all students is regularly monitored and reviewed. Initially, concerns registered by teachers, parents/carers or other agencies are addressed by appropriate differentiation within the classroom and a record is kept of strategies used. This can be then used in later discussions if concerns persist.

How we identify and support students with SEND

All students' attainment and achievements are monitored by their teacher who is required to provide high quality teaching and learning opportunities differentiated for individual students. Where a student is making inadequate progress or falls behind their peers, additional support will be provided under the guidance of the class teacher. Adequate progress could:

- Be similar to that of peers;
- Match or better the students' previous rate of progress;
- Close the attainment gap between the student and their peers;
- Prevent the attainment gap growing wider.

Where students continue to make inadequate progress despite support and high quality teaching, the class teacher will work with the school's Special Educational Needs and Disabilities Coordinator (SENDCo) to assess if a student has a significant learning difficulty and agree appropriate support. Details of some of our assessment tools and materials used in our school can be found in **Appendix 2**.

In some cases it may be necessary to seek assessment by or advice from an external professional such as a specialist teacher or educational psychologist. This will always involve discussion and agreement with the student's parents/carers.

When considering whether a student has a special educational need any of the following may be evident:

- Makes little or no progress even when teaching approaches are targeted particularly in a student's identified area of weakness;
- Shows signs of difficulty in developing literacy or mathematics skills which result in poor attainment in some curriculum areas;
- Persistent emotional or behavioural difficulties which are not ameliorated by appropriate behaviour management strategies;
- Has sensory or physical problems and continues to make little or no progress despite the provision of specialist equipment;
- Has communication and /or interaction difficulties and continues to make little or no progress despite the provision of an appropriate differentiated curriculum;

- Has emotional or behavioural difficulties which substantially and regularly interfere with the student's own learning or that of the class groups, despite having an individualised behaviour support programme;
- Has SEND or physical needs that require additional specialist equipment or regular advice or visits by a specialist service;
- Has a communication and/or an interaction difficulty that impedes the development of social relationships and causes a substantial barrier to learning.

Assess, Plan, Do and Review

Where a student is identified as having SEND, we will take action to support effective learning by removing barriers to learning and put effective special educational provision in place. This **SEND support** will take the form of a four-part cycle through which earlier decisions and actions are revisited, refined and revised with a growing understanding of the student's needs and of what supports the student in making good progress and securing good outcomes. This is known as **the graduated approach – assess, plan, do, review**. The graduated response can be applied to all of the student's journey through school, as part of the Universal Offer (see Appendix 1, the Child and Young Person's Journey, Children, Young People and Families Alliance).

For students with low level special educational needs identified as needing 'SEN Provision', parents will be invited to meetings with either the SENDCo or a member of the SEND Department. A personalised plan will be established for the student, with the young person and parents/carers being consulted in the process. This will identify the young person as requiring SEN provision and will involve the graduated approach. For those students with more complex needs or where a more frequent cycle needs to be employed, additional meeting dates will be set to consider provision through the Early Help Offer, reviews of a young person's 'Action and Review' plan. Early Help provision will be considered if parents, the school or other agencies raise concerns about a student's complex needs or consider a more regular review procedure would be beneficial to the young person and family. Parents/carers will work with professionals, identified with parents/carers from education, health or social care for their child, holding reviews through Team Around the Family (TAF) meetings (see Appendix 1).

Graduated Response

Assess

Assess

- In identifying a student as needing **SEND support** the class teacher, working with the SENDCo or other school-based professional, should carry out a clear analysis of the student's needs. This should draw on the teacher's assessment and experience of the student, their previous progress and attainment, as well as information gathered from other areas of the school.
- The student's development in comparison to their peers and national data should also be considered along with the parent's views and experience, the student's views and, if relevant, advice from external support services. These will be recorded on a personalised plan; this also may involve an initial assessment through an Early Help Assessment and Plan and Review documentation. The school and parents/carers will meet, where appropriate, with other agencies including those from Health and Social Care to create and up-date the personalised plan/Early Help Plan and Review Plan.
- This assessment will be reviewed regularly to ensure support and intervention are matched to need, barriers to learning are identified and overcome so that a clear picture of the interventions put in place and their impact is measured. With some areas of SEND, the most reliable method of developing a more accurate picture of need will be the way in which the student responds to an intervention.

Plan

- Parents/carers, with their child, will meet with the SENDCo or other school-based professional to decide on the interventions and support to be put in place as well as the expected impact on progress and development. This will be recorded on relevant school or Early Help documents with a date to review the plan. The date for review will depend on the level of need present.
- The plans will clearly identify the areas of needs, the desired outcomes, the support and resources provided, including any teaching strategies or approaches that are required and when the plan will be reviewed
- The support and intervention provided will be selected to meet the outcomes identified for the student, based on reliable evidence of effectiveness and will be provided by staff with appropriate skills and knowledge.
- The plans will usually involve a contribution by parents/carers to reinforce learning at home.

	<ul style="list-style-type: none"> Where appropriate, plan will detail the support from other agencies and how this will support the student in achieving the desired outcomes - this could be on the school's plan or through the Early Help Plan and Review Document. <p>So, if it is agreed that a student requires SEND support, all parties meet and develop a school plan or Early Help Plan and Review Document detailing the support which will bring about the next part of the cycle –</p>
Do	<ul style="list-style-type: none"> The class teacher remains responsible for working with the student on a daily basis and will work closely with any teaching assistants or specialist staff involved, to plan and assess the impact of support and interventions and how they can be linked to classroom teaching. The SENDCo or other school-based professional will support the class teacher in the further assessment of the student's needs, in problem solving and advising on the effective implementation of support. The class teacher is equally responsible for the daily implementation of the plan and will contribute to reviews of the provision.
Review	<ul style="list-style-type: none"> There will be a review of the school plan or Early Help Plan and Review on the date previously agreed. This review will evaluate the impact and quality of the support and interventions and include the views of the student and their parents/carers. Parents/carers will be given information about the impact of the support and interventions provided enabling them to be involved with planning the next steps. Where appropriate other agencies will be asked to contribute to this review. Where a student has complex needs involving more than one agency it will depend on the student's needs and the frequency of the educational reviews as to whether external agencies attend each educational review, this will be agreed with parents / carers. This review will feedback into the analysis of the student's needs, then the class teacher, working with the SENDCo or other school-based professional, will revise the support in light of the student's progress and development, with decisions on any changes made in consultation with the parent and the student. Where there is a sustained period of insufficient or no progress, the school may decide to gain involvement and advice from a specialist or external agency. The school will consult with parents/carers before involving a specialist or external agency

Exit Criteria

When a student has made sufficient progress in their area of need that they no longer require any provision that is ***different from*** or ***additional to*** that which is normally available as part of high quality and differentiated teaching they will no longer be seen as requiring SEND Support. At this point, through discussion and agreement with parents/carers the student will be removed from the school's SEND data file.

Statutory Assessment of Needs (EHCP)

Where, despite the school having taken relevant and purposeful action to identify, assess and meet the Special Educational Needs and/or Disabilities of the student, the young person has not made expected progress, the school or parents/carers should consider requesting an Education, Health and Care (EHC) needs assessment. The evidence gathered through the regular SEND reviews will help the Local Authority (LA) in determining when this statutory assessment of needs is required.

Where a student has an Education Health and Care Plan (EHCP), the Local Authority must review the plan every twelve months as a minimum. Schools have a duty to co-operate and will hold an annual review meeting on the behalf of Devon LA and complete the appropriate paperwork for this process.

Monitoring and Evaluation of SEND

Regular monitoring of the quality of provision for all students including those with SEND follows the school's assessment and monitoring calendar. In addition the cycle of Assess, Plan, Do and Review ensures that students with SEND have their individual provision reviewed regularly, and at least termly. Additional training, advice and support will be provided to teaching staff where necessary in order to facilitate student progress and to meet student needs.

Student progress is tracked termly at the school, and where students are not making sufficient progress additional information is sought and appropriate action taken.

Supporting Students and Families

We value and accept the positive role and contribution parents/carers can make. We make every effort to work in full cooperation with parents/carers, recognising and respecting their roles and responsibilities. Parents/carers are encouraged to work with the school and other professionals to ensure that their child's needs are identified properly and met as early as possible.

In order that they play an active part in their child's development, the school endeavours to provide parents/carers with the relevant information so they can reinforce learning in the home.

At The Park Community School, we endeavour to support parents/carers so that they are able to:

- Feel fully supported and taken seriously should they raise a concern about their child;
- Recognise and fulfil their responsibilities and play an active and valued role in their child's education;
- Understand procedures and documentation;
- Make their views known about how their child is educated;
- Have access to information, advice and support during assessment and any related decision-making process about special educational provision.

The SENDCo will do their best to meet with parents/carers, without prior arrangement, whenever possible. Parents/carers of a child who is supported in school by other school-based professionals will meet regularly as specified by the school or Early Help Plan.

Parents/carers are encouraged to seek help and advice from Independent Information Advice and Support services, including Devon Parent Partnership (DPP) <https://www.devonias.org.uk/> These are able to provide impartial and independent advice, support and information on special educational needs and disabilities.

Parents/carers are also encouraged to visit the Devon County Council Local Offer website www.devon.gov.uk/send This website provides valuable information about different agencies, services and resources for children, young people with SEND and their families in addition to school resources and information. A link is also on the website of The Park Community School.

Children in Care

When a child is in care, the carers are accorded the same rights and responsibilities as parents. The school has both an appointed senior member of staff (Assistant Headteacher) and a governor for Looked after Children.

Student Voice

We hold the views of students highly and recognise the importance of gaining genuine student views in promoting the best student outcomes. Students are able to share their views in a number of different ways (appropriate to age and ability).

These views are welcome at any time but are specifically sought as part of their Annual Review, as part of any Student Progress Meetings and at the end of a targeted intervention. We ask all students to contribute to the setting of their own outcomes. Students with SEND are represented on the Student Council in addition to a SEND Student Forum Group, which meets every term.

Partnership with External Agencies

The School is supported by a wide range of different agencies and teams. The school's SEND Information report details which agencies the school has worked with in the last 12 months. This report can be found on the school website and is up-dated annually.

Transition

A change of school, class and staff can be an exciting, yet anxious time for all students. We recognise that this can be very challenging for some students with SEND. We endeavour to make sure these periods of change are carefully managed in a sensitive way to provide continuity of high quality provision and reassurance to students and families. Our processes for transition are explained further in **Appendix 2**.

Training and Resources

Allocation of resources

- Resources are allocated to support children with identified needs as identified previously.
- Each year we map our provision to show how we allocate human resources to each year group; this is reviewed regularly and can change during the academic year, responding to the changing needs within our classes.
- This support may take the form of differentiated work in class, support from a Teaching Assistant (TA) in focused intervention in groups, or for individuals.
- Specialist equipment, books or other resources that may help the student are purchased as required

Continuing Professional Development (CPD) for Special Educational Needs

- The SENDCo and other Staff members provide regular CPD to other staff in school in specific aspects of meeting the needs of students with SEND – a programme covering a variety of needs is offered

- All staff have regular CPD meetings. The progress of all students including those with SEND is a core aspect of the appraisal process and appraisal targets will look at how to develop staff skills in meeting individual student needs as necessary.
- Teaching Assistants are engaged in fortnightly training whereby the role of the Teaching Assistant is developed in their role to enhance teaching and learning.
- External trainers are brought in periodically to address more specialist training needs such as dealing with specific medical conditions (e.g. epilepsy) or to train staff in the use of specific interventions.
- Peer support and guidance is available daily for all staff in school and some of the best training development occurs through professional dialogues with colleagues looking at meeting the specific needs of a student.

Funding

Funding for SEND in mainstream schools is mainly delegated to the schools' budget. It is the expectation that schools provide support to their students with SEND from their SEND budget. Where a student requires an exceptionally high level of support that incurs a greater expense, the school can make a request for Additional Resource using the DAF 3.

The school will need to be able to demonstrate how it has spent the funding to date and the impact of this as well as demonstrating why further additional funding is required and how it would be used. This additional 'top-up' funding is then paid from the local authorities high needs block into the schools budget.

Personal Budgets

Personal Budgets are only available to students with an Education, Health and Care Plan (EHCP) or students who are currently under-going a needs assessment for an EHCP. Funding can be made available to parents/carers as a personal budget for them to commission their own provision for their child under certain conditions.

Parents/carers who would like to enquire further about using the personal budget should speak in the first instance to the SENDCo.

Roles and Responsibilities

Provision for students with special educational needs and disabilities is a matter for the school as a whole. In addition to the Governing Body, Headteacher and SENDCo, all members of staff have important responsibilities.

Governing Board:

The Local Governing Board endeavours to follow the guidelines as laid down in the SEND Code of Practice (2014) to:

- use their best endeavours to make sure that a child with SEND gets the support they need – this means doing everything they can to meet children and young people’s Special Educational Needs;
- ensure that children and young people with SEND engage in the activities of the school alongside students who do not have SEND;
- designate a teacher to be responsible for coordinating SEND provision – the SEN co-ordinator, or SENDCo;
- inform parents/carers when they are making special educational provision for a child;
- prepare a SEND information report and their arrangements for the admission of disabled children, the steps being taken to prevent disabled children from being treated less favourably than others, the facilities provided to enable access to the school for disabled children and their accessibility plan showing how they plan to improve access progressively over time.

Headteacher:

The Headteacher has responsibility for the day-to-day management of all aspects of the school’s work, including provision for children with special educational needs and disabilities. The Headteacher will keep the Governing Body fully informed on Special Educational Needs issues. The Headteacher will work closely with the SENDCo and the Governor with responsibility for SEND.

SENDCo:

In collaboration with the Headteacher and governing body, the SENDCo determines the strategic development of the SEND Policy and provision with the ultimate aim of raising the achievement of students with SEND.

The SENDCo takes day-to-day responsibility for the operation of the SEND Policy supported by other school-based professionals and co-ordinates the provision for individual children, working closely with staff, parents/carers and external agencies. The SENDCo provides relevant professional guidance to colleagues with the aim of securing high-quality teaching for children with special educational needs.

Through analysis and assessment of children’s needs, and by monitoring the quality of teaching and standards of students’ achievements and setting targets, the SENDCo develops effective ways of overcoming barriers to learning and sustaining effective teaching.

The SENDCo liaises and collaborates with class teachers so that learning for all children is given equal priority.

The principle responsibilities for the SENDCo include:

- Overseeing the day-to-day operation of the SEND Policy alongside other school-based professionals;
- Coordinating provision for SEND students and reporting on progress;
- Advising on the graduated approach to providing SEND support – Assess, Plan, Do, Review;
- Advising on the deployment of the school's delegated budget and other resources to meet students' needs effectively;
- Monitoring relevant SEND CPD for all staff;
- Overseeing the records of all children with special educational needs and ensuring they are up to date;
- Liaising with parents/carers of children with special educational needs;
- Contributing to the in-service training of staff;
- Being a point of contact with external agencies, especially the local authority and its support services;
- Liaising with other schools, educational psychologists, health and social care professionals and independent or voluntary bodies;
- Liaising with potential next providers of education to ensure a student and their parents/carers are informed about options and a smooth transition is planned;
- Monitoring the impact of interventions provided for students with SEND;
- To lead on the development of high quality SEND provision as an integral part of the school improvement plan;
- Working with the Headteacher and the school governors to ensure that the school meets its responsibilities under the Equality Act (2010) with regard to reasonable adjustments and access arrangements.

All Teaching and Non-Teaching Staff:

- All staff are aware of the school's SEND Policy and the procedures for identifying, assessing and making provision for students with special educational needs.
- Class teachers are fully involved in providing high quality teaching, differentiated for individual students. This includes reviewing and, where necessary, improving, their understanding of strategies to identify and support vulnerable students and their knowledge of the SEND most frequently encountered.
- Class teachers are responsible for setting suitable learning challenges and facilitating effective special educational provision in response to students' diverse needs in order to remove potential barriers to learning. This process should include working with the SENDCo and other school-based professionals to carry out a clear analysis

of the student's needs, drawing on the teacher's assessment and experience of the student as well as previous progress and attainment.

- Teaching Assistants will liaise with the class teacher and SENDCo on planning, on student response and on progress in order to contribute effectively to the graduated response, (assess, plan, do, review).

Meeting Medical Needs

The Children and Families Act 2014 places a duty on schools to make arrangements to support students with medical conditions. Individual healthcare plans will specify the type and level of support required to meet the medical needs of such students.

Where children and young people also have SEND, their provision should be planned and delivered in a coordinated way using the appropriate paperwork. For those students with an Education, Health and Care (EHC) plan this will be used as it brings together health and social care needs, as well as their special educational provision.

The school recognises that students at school with medical conditions should be properly supported so that they have full access to education, including school trips and physical education. Some children with medical conditions may be disabled and where this is the case the school will comply with its duties under the Equality Act 2010. ***Please see the schools Medicines Policy for further details.***

Children in Hospital

The Deputy Headteacher (Student Safety, Welfare, Behaviour & Community) is responsible for ensuring that students with health needs have proper access to education will liaise with other agencies and professionals*, as well as parents/carers, to ensure good communication and effective sharing of information. This will enable optimum opportunities for educational progress and achievement.

* E.g. *medical agencies, Hospital School*

SEND Information Report

The school will ensure that the SEND information is accessible on the school website. Governors have a legal duty to publish information on their websites about the implementation of the policy for students with SEND. The information published will be updated annually and any changes to the information occurring during the year will be updated as soon as possible. The SEND information report can be found on the school website.

Monitoring and Accountability

Accessibility

The school is compliant with the Equality Act 2010 and Accessibility legislation. It is fully accessible for wheelchair users and has accessible toilet facilities. The Park Community School staff work hard to develop their accessibility and the schools' accessibility plan detailing how this is being developed can be accessed from the school website.

Storing and Managing Information

Student SEND records will be kept in accordance to the DfE guidance contained in "Statutory Policies for schools" (February 2014) and adheres to GDPR (May 2018) (https://www.gov.uk/government/uploads/system/uploads/attachment_data/file/284301/statutory_schools_policies.pdf)

Responding to Complaints


In the first instance, parent complaints about the provision or organisation of SEND are dealt with through the procedures outlined in the School's Complaints Policy.

If there continues to be disagreement with regard to SEND provision the Local Authority should make arrangements that include the appointment of independent persons with a view to avoiding or resolving disagreements between the parents/carers and the school. This includes access to mediation before tribunal. Parents/carers have a right to appeal to a SEND tribunal at any stage.



Criteria for the Transition Project

We welcome the opportunity to work with those Year 6 children for whom transition to Secondary School will be challenging for both themselves and for those who work with them both at home and at school. At The Park Community School we recognise that the most important information we receive is generated by the Primary School, possibly over a period of five or six years. Therefore it is vital that we assimilate and disseminate that information in order to give Year 6 children the best possible start to their secondary school lives. In order to select children to take part in the Transition Project, which is run by our HLTA, we

have established a set of criteria for entry. The criteria are set out below in three distinct groups so that we can identify those with different needs:

Transition Group	Criteria for Entry
The “vulnerable” needing the Self Regard Transition Group	<ul style="list-style-type: none"> ● Children with anxiety/mental health issues ● Children worried about change and overawed by secondary school ● “Victims” with a history of being bullied ● “Lonely children” who may need a contact point or help with establishing a friendship group ● Poor school attendees i.e. with EWS intervention on a regular basis ● Those with very poor organisational skills
The Behaviour Management Transition Group	<ul style="list-style-type: none"> ● Children who have a history of fixed term exclusion/permanent exclusion ● Children who have been at risk of exclusion ● Children who have had a Behaviour Support Plan or a Pastoral Support Plan
Those children from specific vulnerable groups	<ul style="list-style-type: none"> ● Children in Care ● Children from Travelling communities ● Children with a specific diagnosis from the PCT with ADD/ADHD and who meet any of the criteria in the other groups above ● Children with English as an Additional Language who are recent entrants to the UK
